During the course of the day every rider will have an individual session with our Dressage clinician, Dede Boeninger. Dede is an accomplished rider, clinician and dressage judge. After a short warm up Dede will work with you and help to perfect movements that will be required in your test. She will most importantly give you the exercises that will help strengthen your ride and improve your test scores.

While Dede is improving riders' dressage efforts, small groups will work on skills to better their Cross-country jumping. Working at the level of the rider groups, different types of fences will be ridden and the correct technique for special fences explained. Correct speed and the importance of rhythm to the fences will be exercised. Important rules of cross-country will be discussed and examples shown where applicable.

We will start with a good warm up to loosen up both the horses and the riders after the Saturday efforts. We will work on stadium fences keeping riders at the levels they hope to compete at. Riders will work on position, technique, approach and rhythm to their fences. Everyone will work on combinations and the more advanced riders will be challenged with more complicated lines. All riders will work on some simple courses suited to their level. We will also discuss proper striding in combinations, fence types, as well as typical traps that a course designer might add.
